

PRESIDENT'S MESSAGE

The Theme for the 2013 Celebrations has been **"Behold I stand at the door and knock"** (Revelation 3:20). The May Friendship Day Celebration began the theme with "Swinging Wide the Doors of Hospitality". We found ways to minister to one another, looking for opportunities to open wide the door to God's people, whoever they are and wherever we meet them on our faith journey.

Christmas In September is a Celebration unique to Tucson. The organizations, Clinica Amistad, Casa Paloma of Primavera, Pima County Jail Ministry and Salvation Army, were acknowledged for their service to the community and gave participants an opportunity to support their vital service.

The Human Rights Celebration continued the theme with "Breaking Down the Doors of Injustice" and celebrated Lisa Hopper of World Care with the 2013 Human Rights Award. They are endowed with reason and conscience and should act toward one another in a spirit of brother/sisterhood. YOUNG CHURCH WOMEN

in Tucson

In 2013, seven young women nominated by their church will be recognized and honored at the World Community Day Celebration (see page 1).

In 2000, the Board of Church Women United in Tucson committed to extend the invitation to young women to become involved with our Movement. We began acknowledging young women who were recommended by their home church/community. Historically, these young women were acknowledged as Young Church Women at each May Friendship Day Celebration. We have recognized up to thirty young women from churches all over the valley since that time.

CWU in Tucson has a rich and varied history of study, prayer and advocacy from 1941 on, which was a vital part of the growth of rights and privileges we all enjoy today, even take for granted. We believe that the vision and vitality needed for the future of ecumenical engagement is essential for our growth and effectiveness and we want your help exploring how to strengthen the witness of Church Women United to her mission.

The original Young Church Woman Initiative was passed by the National Board of Directors in 2000. The stated purpose was to bring young women's perspective to the national board .The term Young Church Woman United emerged following the state retreat at the 2004 Common Council meeting in Mesa. The young women who participated there were under 40. After the retreat, the age range was set at 21-45 at the Common Council in Mesa.

A National document dated January 2005 invited young women 20 and older to participate in a National YCWU 2005 retreat. Several national retreats have been held since that time. Vera Lander had the privilege of attending one conference when she was serving as National Vice President. The last one was held in Chicago in August 2013.

OUT AND ABOUT! Church Women United is well represented.

9/24/13 Carolyn, Teena and Vera joined Joe and Corrine Bartell and Jonathan Taylor of Pima Friends Meeting on a trip to Phoenix to join a Stakeholder meeting of parties proposing to create a comprehensive **dental health care plan** for AZ children. Senator Linda Sen. Lopez called the meeting of interested parties in which at least thirty attenders represented health care programs attended the meeting. A follow-up conference call on October 30.

9/21/13 Phyllis Hallman organized the **Human Trafficking Workshop** held at Saguaro Christian Church which began with a lunch catered by Café 54. The program included presentations by Border Patrol agent-Leslie Lawson and a representative of the International Rescue Committee. The statistics provided for women, children and sometimes men that are caught in trafficking were overwhelming, heartbreaking and enlightening. Massage parlors, nail spas, manicure-pedicure businesses, sweat shops, domestic workers, forced prostitution are all possible forms of trafficking. We are encouraged to be alert for signs of individuals being held against their will.

9/27-29 A More Light conference sponsored by LBGTQ and Wingspan was held at St. Mark's Presbyterian Church. **The Reveille Men's Chorus** closed out the Saturday workshop with a concert that lifted our spirits.

10/6/13. The Sacred Presence was celebrated in the **5th Annual Multi-Faith Pride Service** held in the beautiful Scottish Rite Temple in downtown Tucson. The celebration included a diverse program of music, dance and speakers who made the Divine Presence felt among us.


10/8/13 At Casino del Sol a representative from the **Arizona Health Care Cost Containment System** office presented an **update on the extended AHCCCS legislation**. Of note is the introduction of an on-line application system that will ultimately communicate with the Affordable Care Act system, reducing the duplication of effort by applicants.

10/11/13 **Herbert Residential** is the new name of the Armory Park apartment building. The Grand Opening was attended by the Mayor and Council members. The architect and builders described the intended residents to be graduate students and independent older citizens. Members of the community were fully represented and are thrilled with the new levels of citizen activity downtown. The Tucson High School Steel Drum Band provided lively entertainment.

10/13/13 Jonnie Mathe hosted **Phillip's Chapel Christian Methodist Episcopal** church at a Read-in, a program of readings, skits, music, lively worship and a "rocking" children's group,

10/19/13 **The United Nations Association of Southern Arizona** hosted a presentation by Micah Spangler, Deputy Director for Legislative Affairs of the United Nations Foundation, which is the lobbying arm in Washington DC for the UN. CWU was one of the first Non- Government Organizations to be an Official Observer to the United Nations when formed in 1945 [Just Because, Margaret Shanno, 1977.]We are re-kindling our relationship with the local UN Association by being in contact with Joan Safier and office staff. Micah was given contact information for Stephanie Jones at the Legislative Affairs office of CWU.

10/20/13 **The Clinica Amistad** held a Fundraiser Dinner, raffle and silent auction at the beautiful Most Holy Trinity Church in west Tucson. The Davis Elementary School Mariachi Band provided entertainment throughout the evening. Clinica Amistad was one of the Christmas In September recipients this year.

This question has been on my mind for years, and as I approached my graduation in May 2013, I had to ask myself what this would look like post-college. Graduate school? Campus ministry? An entry-level job? Ameri-Corps?

These options all seemed plausible and worthwhile, but none completely matched the yearning of my heart—to integrate my Christian faith with the pursuit of justice. Since high school, when I started participating in one-week mission trips, I wanted to find a career path that would allow me to seek justice in my every-day work. I wanted to switch from the perpetual "honeymoon phase" that accompanies one-week trips and experience the ups and downs of social justice work on a daily basis.

December 2012, I learned about Young Adult Mission Service (YAMS) and the US-2 program, a domestic faith and justice centered mission service program for adults ages 20-30. My application was accepted and I spent three weeks training in New York. I was commissioned in August and shortly after moved to Tucson, Arizona to begin my service with my placement site, Iskashitaa Refugee Network, as a US-2 missionary of The United Methodist Church. This was the perfect match for me because I identified with Iskashitaa's mission, which is to assist refugees on their journey of adapting to life in the U.S.A. through food-based programming.

Through July 2015, I'll work with Iskashitaa as Food Justice Coordinator. My primary role will be working with the food preservation workshops and to serve as a faith-based group liaison. I'm excited about the opportunity to work with refugees from various countries. I also look forward to helping build and strengthen connections and partnerships between Iskashitaa and area churches, all while increasing my understanding of food justice.

As a Battle Creek, Michigan native, this is my first time in the southwest part of the United States. The joys and challenges of experiencing new cultures and new people while pursuing justice will be invaluable to my growth as a person and as a Christ-follower. I'm thankful for the warm welcome I have received and I'm excited to begin learning from and working alongside the people of The Desert Southwest Conference.

Judy Bodnaruk--Our speaker (Beverly Phillips).....using her own experience with prayer, especially journaling, to lead us to new insights and different ways of praying. Jane Rohwer--The surprise of learning that prayer beads are [ecumenical]. I liked it. Alice Brown--Getting the prayer beads and learning how to use them to focus my prayers....for me in praying for my family. Teena Cross--Better understanding of prayer beads and how they enhance prayer life. I can't let go of them. Vera Lander--The prayer beads captured my heart....I hold and use them when I walk now; also the opening up of overlooked aspects of scripture [about the nature of God]. Carolyn Redmore--the reframing of creation and God as creator.....that creation is ongoing as is God's immersion in it; also the experience of doing my mandala.....feeling sustained by the group's silent communion.

Treasurer, Martha DeWarf, 2107 N. Catalina, Tucson, 85712. "How much" is the local group's call. Remember, Shares of Responsibility are the backbone of the work of the local CWU. You know-- the essentials that keep the "office" functioning and allows us to support leaders going to two annual state meetings, quadrennial regional and national meetings.

Third, Now is 2014 budget setting time for many church groups. Plan now for the 2014 commitment to Church Women United. Many of us had to cut back a few years ago. The local women's group I belong had to do so, but for the coming year increased its Share of Responsibility. Consider a 10% increase, or more if the Spirit so leads you.
