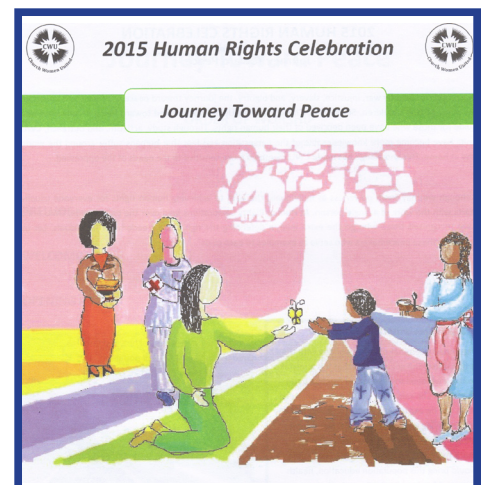

# CWU Southwest Regional Event

August 2014 - San Francisco, CA

*“Building Bridges”* the theme for the Southwest Regional Event, did just that for me. This was my first Regional Event. Not knowing what to expect, I initially had my “critique hat” on, evaluating each aspect of the program as it presented itself. In spite of where my head was, initially, as I met women from around the Region, I felt the bond of sisterhood; the caring and love that was shown from each and every person that we met. It was also good to be in the company of **Vera** and **Judy** who already knew some of the people of the Region, so I didn’t feel so much like a fish out of water.

Friday evening highlights were soloist **Marilyn Reynolds** – magnificent voice and speaker **Rev. Tracy Freeman** of the American Baptist Seminary of the West. Rev. Freeman is a young woman with much energy and passion. I was impressed with the fact that during dessert, she went around the room and greeted all of the ladies at each of their tables before she was to speak. Rev Freeman spoke of our society that is broken and lonely and that there’s a lot of separation. We are called to selflessness and to build bridges to help ourselves and others with the pain of life. The only bridge that needed to be built has already been built, God the spirit. God has provided the substance to fill all the voids and hurts. Travel across the bridge that has already been built. The Present is the only reality that we have, right here, right now!

Saturday morning our Bible study was led by our own **Sybil Eppinger**. She followed the theme of ‘bridges’. Sybil brought to our attention that the word “bridge” is not found in the scriptures. Isaiah 58:12 refers to “repairer of the breach or restorer of streets”. She described different types of bridges historically and brought us to understand that a bridge invites transition in ones life. Change is the only constant that we can be sure will occur. Transitions were expanded upon and described in 3 stages: 1st stage- “letting go”, or the Bridge of Faith, Biblical example was Rebecca in Genesis 24; 2nd stage – “Neutral Zone”, or the Bridge of Love. It takes love to “hang in there”, Biblical example was Ruth 1:16; and finally 3rd stage – taking hold of the new or the Bridge of Hope. Willingness to take a risk, Biblical example was Esther. So we are exhorted to encourage and build up each other on our bridge journey.

Also a part of the morning program was the opportunity to meet and hear presentations by **Marilyn Lariviere**-National President, **Margit Hauge**-National Vice President and **Djamillah Samad**-National Executive. These ladies gave us a brief CWU 101 course, providing us with general information about CWU, how the National Office functions and National expectations of the local units. We were informed that the 2015 theme is *“Companions on a Journey”* and the National Convention will be in

Louisville, KY, October 14 – 16, 2016, and CWU will be celebrating 75 years. Additionally, I had the opportunity to have breakfast with Djamillah and then Vera, Sybil and I had the pleasure of meeting with Marilyn to share concerns and also some programming suggestions.

Saturday afternoon involved multiple workshops: *Bridges to Mercy Ministries, Bridges to Peace, Bridges to Advocacy and Justice, Bridges to Spiritual Growth, Bridges to Wholeness and Bridges to Each other-communications*. I attended the workshop on Advocacy and Justice. Our workshop leader was **Monika Grasley** whose passion has been to look beyond the barriers people and communities face and look for the potential of people. She is the director of LifeLine CDC, a non-profit organization in Merced CA, whose passion it is to “Empower Impoverished Neighborhoods to Thrive”. They look for the image of God in people and neighborhoods and work together to bring the Shalom of God into people’s lives and neighborhoods. Mrs. Grasley provided us with some recommended steps for building bridges to justice and advocacy: 1-Evaluate your ministries and the way you see people; 2- Learn more about Justice Ministries and 3-be a voice for the voiceless. Become an advocate. She emphasized the ability to identify the ‘Mercy/Relief Ministry’ which addresses a crisis situation and is short term vs ‘Development/Justice and Advocacy’

which addresses a chronic situation and is long term.

Saturday evening we were blessed with another dynamic vocalist – **Marlynn Smith** and our speaker for the evening was **Bronwyn Galloway** who is Executive Secretary & Chair of Women’s Committee, San Francisco Chapter of the UN Association of the USA. Ms. Galloway shared the current declarations of the UN in regards to women and children’s issues.

Our evening worship was led by the CWU Colorado unit and the focus was on “courageous women”. The scripture was taken from a book most of us are not familiar with. The reading was from Judith. One Bible version where it can be found is the Jerusalem Bible in The Historical Books. The message was how Judith, against all odds, was able to save her people of Bethulia from Holofernes who was the ‘General’ of the Assyrian army. One of the Bible’s great women of courage!

Sunday morning was a Hallelujah Sunday. Beautiful morning in San Francisco and worship was led by **Rev. Virginia R. Greeley** who is ordained in the Christian Church (Disciples of Christ). Rev. Greeley is the president of Southeast of the So California/So Nevada State Unit. So dynamic! Her sermon title was “Answer the Call” and as she proceeded with her message she included the “bridge” references that were made by the other speakers throughout the weekend. Wrapped it up beautifully. Communion followed and concluded with all of us sisters holding hands and forming a circle around the room. Spirit filled worship! Hallelujah and Amen!

Thank-you for this great opportunity to meet, greet, share with and get to know CWU sisters in the Southwest Region.

The next Southwest Regional Event will be in 2018 and will be hosted by the So California/So Nevada State Unit. I pray that we will have a large contingency planning to attend.

# Church Women United Support Ecumenical Women

**The following excerpts highlight what Church Women United, through Ecumenical Women, has presented to the United Nations' CSW59/Beijing +20 on your behalf.**

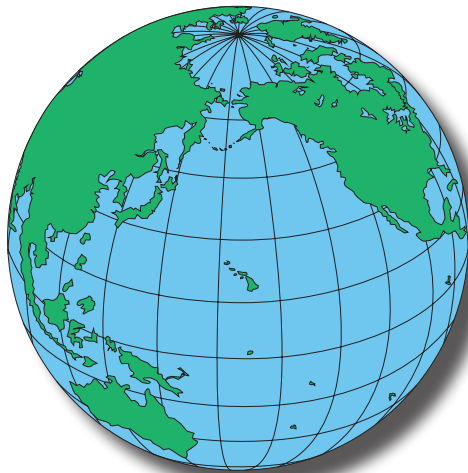
*The following members of Ecumenical Women have submitted this statement to the 59th Commission on the Status of Women: Anglican Consultative Council, Association of Presbyterian Women of Aotearoa (New Zealand), Church Women United, Domestic and Foreign Missionary Society of the Protestant Episcopal Church in the USA, Lutheran World Federation, Presbyterian Church (U.S.A.), The Salvation Army, Society of Catholic Medical Missionaries, United Church of Christ, United Methodist Church – Women's Division of the General Board of Global Ministries, Women's Missionary Society of the African Methodist Episcopal Church, World Federation of Methodist and Uniting Church Women and the World Young Women's Christian Association, with support from the Global Action on Ageing, the National Council of Churches of Christ (USA) and Presbyterian Women in the Presbyterian Church (USA).*

Ecumenical Women, a coalition of Christian denominations and organizations, welcome the review of the Beijing Platform for Action at the 59th session of the Commission on the Status of Women. We affirm the promotion of gender equality, development and peace as fundamental to realizing women's human rights,

as declared in the Beijing Platform for Action, Convention on the Elimination of all Forms of Discrimination Against Women (CEDAW), Security Council Resolution 1325 and other international agreements.

We condemn oppression, violence and women's exclusion from political and social processes using religious beliefs to legitimize such practices in conjunction with political interests.

The state has the primary responsibility to prevent violence and discrimination and to promote and protect the economic and social human rights of women and their families. As churches and faith-based organizations, we also play a role through advocacy and education.



Progress has been made since the first world conference on women in 1975 and there have been important steps towards gender equality. More women now have access to education and health care. Rape and violence against women is now globally understood as a crime. Despite the twenty years of

national and international agreements to advance women's rights, many of the goals of the Beijing Platform for Action remain unfulfilled. Gender biased institutional structures create inequalities and discrimination, and still exist in public and private sectors, academia, and religious structures. We are concerned with the lack of full implementation of the Beijing Platform for Action and the efforts to roll back gains. In this year of assessment 20 years after the Beijing Platform for Action, Ecumenical Women highlights the following themes that require action by all states to advance women's human rights:

- **Violence and discrimination against women**
- **Poverty, inequalities and climate change necessary to reduce climate change-related disruptions.**
- **Education and training of women and girls**
- **Women and health - full access to reproductive health and informed decision-making**

**We ask Member States to:**

- Affirm the right of women and men, especially young people, to have access to comprehensive sexual reproductive health education and services;
- Reverse trends to privatize public health systems and fully fund women's health infrastructure, including reproductive health services;
- Emphasize and respond to the growing feminization of HIV/

AIDS and provide full access to health services and medicine;

- Promote closer partnerships with civil society, faith-based organizations and the United Nations in order to increase the capacity for care and support;
- Provide full access to health care for all women and girls.
- We affirm that God's world was meant to be one of abundance for all people, with fundamental rights and dignity for all women and men. For healthy sustainable societies, women must be integral to the decision-making processes in law, policies and development programs. Women are needed at the center of post 2015 development agendas.

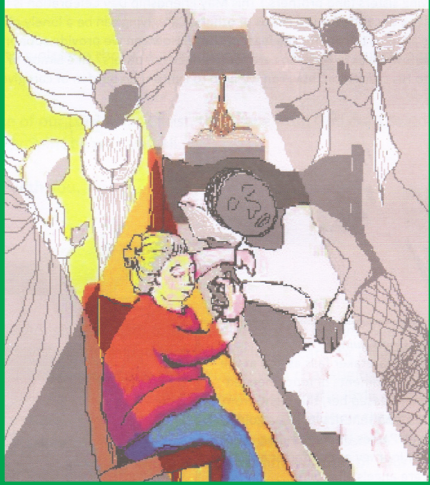

# CWU State Assembly 2015 Meeting: January 23-24

## “Bridging The Gap - Keeping Families Together”

What a marvelous weekend at the RiverPark Inn, Tucson! Tucson Church Women United planned an inspirational, informative, enriching 2015 State Assembly with outstanding musical offerings. **MarJean Shute, Linda Stepenoff, Sybil Eppinger, Sue QuareQuio** and **Sharon Davids** represented the Phoenix unit and were eager to share their excitement.

Friday evening’s worship/communion service was led by the **Rev. Alison Harrington** of Southside Presbyterian Church. The service also included the Sacred Jazz Ensemble, also from Southside Presbyterian Church. Other music was provided by **Jose Serrano** and **Estella Garcia** from Most Holy Trinity Catholic Church adding to our spiritual growth.

Saturday Morning included election and installation of state officers. **Alice Brown** begins as Arizona Church Women United President. Immediate past president **Flinn Lund** fills Vice-presidency, **Bobbie Norris** will fulfill the role of Treasurer and manage the Resources and **Kathie Mittlestead** continues as our most

capable Secretary. **Sharon Davids** will be heading Communications. **Sybil Eppinger & Vera Lander** will be responsible for Ecumenical Development. **Teena Cross & Judy Bodnaruk** will lead the Nominating Committee

Following the business meeting, the morning’s panel consisted of the **Rev. John Fife** who spoke of his involvement in the Sanctuary movement in the 1980s. He emphasized that this is not a new idea, citing examples from biblical times. At this time, 230 congregations provide Sanctuary in the United States. **Margo Cowan** informed us of the legal matters/guidelines when providing Sanctuary. Sanctuary will: 1. provide a safe place for an individual to stay with 24 hour volunteer presence; 2. stop deportation of an individual and 3. prevent an individual from being separated from their family as well as gives support to that family.

Saturday afternoon, a panel of three gave informative dialogue related to their organization’s involvement in Bridging the Gap to help Keep Families together. Rev. Harrington

informed us of Sanctuary at Southside Presbyterian Church; **Sarah Roberts** spoke about No More Deaths and **Marjorie King** spoke about her prison ministry with detainees in Eloy.

We attended A Community Conversation between Angela and Rosa, Daniel, and Francisco on Wednesday 2/25/15; a Potluck, Workshop and Conversation about The New Sanctuary Movement of Philadelphia on Thursday; and took the Campaign to the Postal Workers Union “Jobs with Justice Meeting” and took photos with signs and flyers.

**The Arizona Faith Network**, formerly the Arizona Ecumenical Council, has a new Executive Director. **Reverend Erin Tamayo** is an ordained minister of the Presbyterian Church (USA) and a member of the Grand Canyon Presbytery. CWU AZ President and two other AZ Board Members hold three voting seats (on the past Council).

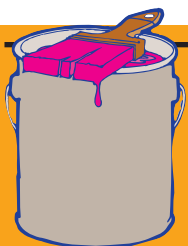

**SB 1282, the “Dental Omnibus Bill”** is currently in the Legislature, with a bipartisan group of eleven co-sponsors, to provide oral health care to children who have no access to dental care. **Vera Landry, Teena Cross, Joe Bartell** and **Corrine Bartell** have participated in the Stakeholder Group during the past two years. AZ Republican **Senators John McCain** and **Jeff Flake** attached a Rider to the **Defense Authorization Bill** that secretly swapped sacred land of the Apache Nation at Oak Flat with an Australian Company with plans for an open pit Copper mine, with exploratory drilling underway already on private land and public right-of-ways, during the seven year period allotted for securing necessary permits.

Forty-seven (47) Republican US Senators signed and sent a **letter to the President of Iran** pledging that they could dismantle any agreement made with President Obama when he is no longer in office. This action has been labeled “Treason” in some media sources.

## Under Construction
